Important Instructions regarding Registration under CU and Payment of Registration Fee

Payment of CU Registration Fee

The registration process of the candidates under the University of Calcutta has already been started. The candidates who take fresh admission at Bethune College during 3rd Phase (from 9.12.2020 to 15.12.2020) and **did not pay registration fee earlier** are required to pay registration fee as mentioned below:

Non-Migrating Candidates :

(Candidates passed 10+2 examination from **WBCHSE/ WBBME/ CISCE/ CBSE/ NIOS/ Rabindra Mukta Vidyalaya**)

General Category students – **Rs.170/-**

SC/ST/OBC/PWD/BPL category students with **valid BPL certificate** – **Rs. 95/-**

Migrating Candidates :

(Candidates passed 10+2 examination from **Boards Other than those mentioned above**)

General Category students – **Rs.270/-**

SC/ST/OBC/PWD/BPL category students **valid BPL certificate** – **Rs. 195/-**

Registration Fee is to be deposited (online transfer via NEFT/IMPS/UPI or other mode) to the following Bank Account of Bethune College within 16.12.2020 :

After successful payment of Registration Fee the candidates are required to take a printout/ screen shot of the payment receipt and to upload it by clicking the following link :

Last date of payment of registration fee and uploading of payment receipt – 16.12.2020

Failing to paying registration fee and uploading of payment receipt within specified time may lead to automatic cancellation of admission. No request for receipt of registration fee beyond the stipulated time will be entertained.

The following categories of students need to upload scanned copies of the specified documents to the above link. **Only jpg/ jpeg format is acceptable.**

- 1) BPL Category – Valid BPL Certificate from competent authority (Max file size 100 KB) [file name B_<Application No>.jpg/.jpeg]**
- 2) Migrating Candidates – Migration/Equivalence Certificate (Max file size 100 KB) [file name M_<Application No>.jpg/.jpeg]**
- 3) Candidates already registered under CU in previous year (2019) – CU Registration Certificate (Max file size 100 KB) [file name R_<Application No>.jpg/.jpeg]**

Please note that the candidates already registered under the University of Calcutta (in 2019) need not pay Registration Fee again. But they have to fill up the form and upload CU Registration Certificate.

The candidates who took admission in other college earlier and whose Registration Applications have been submitted to CU from other college are advised to Cancel their admission from that college and submit Registration Cancellation request to that college immediately after taking admission to Bethune College. They are also advised to submit fresh Registration Application from Bethune College following the above mentioned procedure to avoid future complications.

Instructions for candidates who paid Registration fee earlier and now changed their Honours Subject in 3rd Phase Admission

The candidates who took admission in other subject and already paid Registration Fee need not pay Registration Fee again but required to fill up the following form by clicking the link given below to provide updated information immediately after taking admission :
